


## Hollister 'Tip and Sleeve' Intermittent Catheters Confidence. Pure and Simple.

Hollister Intermittent Catheters feature Touch Free technology, enabling users to catheterise with confidence, without ever having to touch the sterile catheter or to expose it to possible environmental contamination. Hollister Touch Free technology can be found in the Advance/Advance Plus, InstantCath and VaPro Intermittent Catheter ranges.

## Relative recovery of Staphylococcus aureus and Escherichia coli on catheter E was significantly lower than that recovered from traditional catheters.

Laboratory tests compared traditional catheters with the Advance Touch Free Intermittent Catheter to determine whether the protective sleeve affects the degree of contamination of the catheter during preparation and insertion. Results showed that intermittent catheters with the hygienic feature of a Touch Free sleeve helped reduce the potential for external contamination during preparation and insertion. This may help reduce the risk of bacteria entering the urinary system, a cause of urinary tract infection.

#### RELATIVE RECOVERY OF STAPHYLOCOCCUS AUREUS & ESCERICHIA COLI

#### Q: What is the importance of a protective tip when selecting a catheter?

A: Clinical evidence has shown that the protective tip on an intermittent catheter bypasses the first 15 mm of the distal urethra, and in doing so, reduces the bacteria that are pushed up into the bladder. The protective tip has been shown to reduce the potential for catheter contamination which may help reduce the risk for infection.<sup>1,2,3</sup>

## Q: What are the advantages of having both the protective tip and sleeve features on an intermittent catheter?

A: The protective tip and sleeve help guard against contamination both from the environment and the distal urethra. The protective tip and sleeve allow a no-touch technique to be used, which means there is no direct hand contact on the catheter, thus reducing the introduction of bacteria into the urethra.<sup>1,2,3</sup> These features may help reduce the risk for infection.

# Q: Is there any clinical evidence that shows that a protective tip and/or protective sleeve on an intermittent catheter helps reduce the risk of infection for patients who self-catheterise?

A: Yes. Both the Bennett *et al.* and O'Neil clinical studies indicate that a protective tip on a catheter may help reduce the risk of infection for those catheterising. The Hudson/ Murahata laboratory studies suggested that a gel pre-lubricated intermittent catheter with a true no-touch protective sleeve and protective tip may help reduce the risk of bacteria being transmitted to the catheter.

## Q: What catheterisation technique does the European Association of Urology (EAU) recommend in their Guidelines?

A: Aseptic technique is recommended by the EAU Guidelines as the method of choice.<sup>4</sup> IC in general is the gold standard for the management of neurogenic lower urinary tract dysfunction.

# Q: Have catheters without a sleeve, but use their "wrapper" as a sleeve, ever been compared to a catheter with a true sleeve, and if so, how have they compared when it comes to bacteria level? Which provided better protection from bacterial contamination?

A: Yes. In the Hudson/Murahata study, Catheter D – a hydrophilic catheter handled through the "wrapper" in both cases, had a higher *E.coli* and *S*. aureus level than Catheters E and F, both gel catheters with true no-touch sleeves.

#### **Fitting and Preparation**

- Check for correct size using the Hollister sizing guide (penis should be flaccid) and choose type of sheath (Special, Standard or Extra) as required. Allow for change in penile size e.g. nocturnal erections. If client size is between two, select the larger size.
- Ensure skin is clean and dry and that there is no powder or creams on the skin. If any skin damage or infection is present stop use until skin is healed and manage with alternative products.
- Trim excess pubic hair and/or use a hand towel or square of paper with hole in the middle to hold back pubic hair while applying sheath.
- Follow fitting instructions to apply. Ensure sheath is held in place for 20-30 secs to ensure good skin contact.
- If client is uncircumcised ensure foreskin is forward (un-retracted) before applying sheath.
- To connect this product to a drainage system, refer to the instructions for use packed with that product.

#### Wear time guidelines

• Hollister recommends changing the sheath daily for hygiene reasons and to monitor skin condition. However, provided the skin is intact and healthy, the client may choose to leave the InView Sheath on for longer than 24 hours.

#### Removal

- Disconnect from the drainage system.
- Please follow all local disposal regulations.

### **Trouble shooting**

- **Sheath not sticking well** check application technique. Check skin is dry on application and no creams or talc are in use. Check skin condition.
- Sheath falls off this may be due to penile retraction. Can be a problem noted at night or when in bed. If not using the Special shorter length sheath, the client should be changed to this style to try. If not successful, the Hollister Urinary Pouch (page 32) should be considered.
- Less than expected wear time check as above. Re-check sheath size and type. Check client compliance – with initial use some clients take a while to get used to the feel of sheaths. Check that drainage bag has wide bore tubing to allow for normal flow rates.

Check tension on sheath from drainage appliance – it may need to be adjusted.

- Poor flow into drainage device /pooling of urine in funnel check sheath is
  positioned with urethral opening pointing down the tubing. If tucked downwards, this
  may obstruct flow.
  - Check that drainage device is securely connected to sheath.
  - Check there are no kinks in the tubing and that it is positioned so the bag is below the bladder facilitating gravity flow.
  - Ensure the sheath is not pushed right up against the glans there should be a small gap between the glans and the drainage port. This also helps prevent pooling of urine.
  - Check the sheath is not too tight and obstructing the urethra change to larger size.
  - If a vacuum is created preventing drainage disconnect the tubing to allow drainage and some air into the tubing and reconnect.

**Note:** Do not use on irritated or compromised skin. Do not use if allergic reaction occurs. Not made with natural latex.



#### LIBERTY MEDICAL PTY LTD TERMS AND CONDITIONS OF SALE

Unless otherwise agreed in writing, these terms and conditions (Conditions) govern all contracts for the sale of goods (Goods) by Liberty Medical Pty Limited (ABN 36 072 817 755) (Company) to the customer (Customer). All other terms and conditions, express or implied, are excluded to the fullest extent permitted by law, including any terms and conditions in the Customer's order for Goods (Order).

#### 1. Quotations, Orders and creation of Contract

Any quotation from Company to Customer is submitted on a confidential basis and is an invitation to treat only, not a contractual offer. Company may, in its absolute discretion, reject any Order or accept any Order in whole or in part.

All orders are subject to acceptance of Liberty Medical and Conditions of Sale. Liberty Medical shall not be liable for any failure to perform the contract of supply of any materials or for any delay or non-delivery due to strikes, fires, explosions, flood, riot, lockouts, injunction, interruption of transportation, accidents, inability to obtain supplies at reasonable prices, war or apprehension of war, force majeure, government action, or any other circumstances beyond Liberty Medical's control.

Liberty Medical reserves the rights to request a minimum order value of \$300 per order. All orders less than \$300 will attract a standard freight charge of \$27.50 + GST.

A contract for the sale of Goods (Contract) will be formed, in accordance with the Order and these Conditions, when Company commences the necessary actions on its part to supply the Goods ordered by Customer.

#### 2. Prices

Goods are invoiced in accordance with the relevant quotation or agreement between Company and Customer, or else from Company's price lists current at the date of delivery.

Prices are quoted exclusive of GST and Customer agrees to pay GST in accordance with the tax invoice.

Liberty Medical endeavours to advise the trade of fluctuations in prices, however all prices are subject to change without notice by Liberty Medical.

#### 3. Payment

Unless otherwise agreed in writing, payment for Goods is due within 30 days of the end of the month in which an invoice is issued without deduction or set off. All payments are to be made in cash, by cheque, credit card or direct deposit into the account notified by Liberty Medical. Failure to pay an amount on the due date entitles Company to, without prejudice to any other remedy, suspend delivery of an Order or cancel any Contract. Customer will be liable for all costs and expenses incurred by Company in obtaining (or attempting to obtain) a remedy for any failure by Customer to pay on the due date.

#### 4. Revision of Terms of Payment

If Liberty Medical at any time considers that conditions do not warrant delivery of the goods on the terms of payment stated herein, Liberty Medical reserves the right to change the term of payment and/or require payment as a prerequisite of delivery and will notify the customer accordingly.

#### 5. Handling

Liberty Medical will select the mode and rate for transport of goods. When special handling/order is requested the Customer will be charged the additional premium freight service, the cost of the special service will be added to the invoice.

#### 6. Risk and delivery

Risk in the Goods will pass to Customer upon delivery. Delivery or dispatch dates are given or accepted by Company in good faith, but not guaranteed unless stated to be "guaranteed" in writing. Company will not be liable for any claim for loss or damages if Company is delayed or prevented from delivering goods for any reason.

#### 7. Title

- Property in the goods shall remain with the Company and the Company has clear title to the goods until such time as:
  - full payment is made for all amounts owing by the Customer to the Company so that the Customer's total indebtedness to the Company under these Conditions of Sale is discharged: or
  - (ii) the Customer sells the goods to his customers in the ordinary course of their business.
- b) If the Customer fails to pay any amount of the Customer's indebtedness to the Company under these Conditions of Sale when it is due to the Company or, an event of default as specified in subsection (d) hereof occurs, the Company may withhold notice and without prejudice to any of it's other rights and remedies, recover and/ or resell the goods or any of them and may enter upon the Customers premises by its servants or agents for that purpose.
- c) Until full payment the Customer shall store the goods in a way that clearly manifests the Company's title.
- d) Notwithstanding the provisions of these Conditions of Sale payment shall become due immediately upon the Customer committing any act of bankruptcy or the Customer (being a company) committing any act which entities any person to apply to wind up the Customer, or a Receiver or Receiver and Manager of the Customer is appointed.
- e) The Customer acknowledges that until his total indebtedness under these Conditions of Sale to the Company is discharged he holds the good as bailee of the Company and that a fiduciary relationship exists between them.
- f) In the event of sale of goods to his customers, the Customer in his position as fiduciary shall:
  - (i) assign to the Company the benefit of any claim against a customer, and
  - account fully to the Company for the proceeds of the sale (unless and until the Customer's total indebtedness to the Company under these Conditions of Sale is discharged).
- g) Until ownership passes to Customer, the Customer:
  - must insure the Goods against all usual risks to full replacement value and hold on trust for Company any insurance monies received for the Goods,
  - (ii) must keep the Goods separate and clearly identified as Company's property,

(iii) may sell or otherwise dispose of the Goods in the ordinary course of business, provided Customer holds any proceeds on trust for Company.

#### 8. Returned of Goods

Liberty Medical will accept returns of certain merchandise from the Customer under the following conditions:

- a) All returns must be arranged by Liberty Medical Customer Service Department and a RGA number will be provided. Goods sent without approval will not be accepted and will be re-directed back without issue of credit, at Customer's expense.
- b) Returns must be made within 14 days from the invoice date.
- c) Only full boxes of Goods will be accepted for credit.
- d) Goods accepted for credit where there has been no fault on the part of Liberty Medical, will be charged a re-stocking fee of \$25.00 or 25% of the total value of the returned Goods (whichever is the higher).
- e) Any returned Goods must have an adequate shelf life, require no repackaging and are in an 'as-new' saleable condition. Damaged Goods will not be accepted and will be re-directed back without issue of credit, at Customer's expense.
- Freight for goods returned due to Customer's error will be at the Customer's expense.

#### 9. Non-Returnable Merchandise

- Sterile Products (except as a result of the Company's shipping error), or by arrangement.
- b) Discontinued items.

#### 10. Product Liability

The product liability of Liberty Medical in relation to any occurrence shall never exceed the limit of Liberty Medical's current product liability insurance.

#### 11. Limitation of Liability

Liberty Medical's liability for any claim whatsoever in respect of products sold hereunder shall not in any case exceed the price of the product in respect to which the claim is made and Customer assumes all risks and liability for the products purchased from Liberty Medical and their use upon and after delivery including their effect upon any person. Any and all warranties or conditions express, implied or statutory are excluded except those which cannot be lawfully excluded.

#### 12. Performance

Customer acknowledges, (a) it has relied on its own enquiries concerning the performance of Goods and not on any information, services or recommendation given by Company, and (b) that all descriptive specifications, data, dimensions and weights provided by Company or otherwise contained in Company's catalogues, price lists or other advertising material are approximate only and shall not form part of the contractual description of the Goods unless agreed to in writing by Company, in which case such specifications shall be subject to recognised trade tolerances.

#### 13. Claims

Customer must inspect the Goods upon delivery to ensure the Goods have been delivered in full, are in good working order and free from damage and defects. Any claim by Customer of Goods damaged, lost in transit or short delivered must be made in writing to Company within 7 days of delivery (and must quote the invoice number). Customer must give notice of any defect in the Goods within 7 days of learning of the defect. All Goods that are alleged to be defective must be returned by Customer to Company, if requested, by Company's nominated carrier. Customer will bear the freight cost for the return of Goods which are found not to be defective.

#### 14. Disclaimer

To the extent permitted by law, Company (and its officers, directors, employees, agents or successors) will not be liable for any loss, damage or expense sustained or incurred by Customer or any other party in consequence of or resulting directly or indirectly out of the supply of Goods by Company, the use or receipt of Goods, any breach by Company of any Contract, or the negligence of Company, it is understood that Customer will test and use the Goods as they are intended to be used according to the practices standard in the industry and in strict compliance with all applicable laws and regulations.

Without limiting the generality of the above, Company will not, in any circumstances (including any fault or negligence of Company), be liable for any indirect or consequential losses (including loss of goodwill, business or anticipated savings), loss of profits or use, any rectification costs or any third party claims in connection with Goods or a Contract.

#### 15. Confidentiality

Customer acknowledges that the price of Goods set out in any quotation or Contract, any variation of the payment terms set out in clause 3 and any special conditions agreed in writing between Company and Customer are Confidential Information of Company. Customer may not disclose or otherwise make available such Confidential Information other than to their own employees involved in the Contract, except with Company's prior written consent.

#### 16. Governing Law

Each Contract is governed by the laws of Victoria, Australia and both parties submit to the non-exclusive jurisdiction of the courts of that State.
